Eligibility: All Active Full Time Employees working a minimum of 30 Hours per week.

Coverage amount is a percentage of your weekly earnings just prior to becoming disabled.	60.00% of your weekly earnings to a maximum of \$1,000 per week.

Maximum Benefit Period is the total length of time you can receive disability benefits under this plan; provided you continue to meet the definition of disability as defined by your policy.	12 weeks of benefits

Benefits begin after you complete the Elimination Period. This is a period of time you must be disabled before benefits are payable. This timeframe may be the same or different for accident and for sickness.	Short Term Disability Insurance benefit begins on day 8 after your accident or on day 8 of sickness.

Pre-Existing Condition is a disease or physical condition for which treatment has been received within a defined period of time immediately prior to becoming covered under the plan.	Look Back period: 3/12 Exclusion period: 3/12

If your plan includes a Pre-Existing Condition provision it is displayed as two time periods. (e.g. 3/12)

- *Look Back Period: Number of months prior to the effective date where we look for received treatment or a diagnosis by a physician.*
- *Exclusion Period: Number of months following the effective date where if you become disabled due to a pre-existing condition, then benefits for the disability are excluded*

Lump Sum Survivor Benefit is an additional benefit payable to your family if you die while you are disabled and receiving benefits under thi	3 weeks of the gross disability payment not to exceed \$3,000

Minimum Weekly Benefit is the minimum weekly benefit amount payable for a qualifying disability, regardless of other sources of income.	\$25

Frequently Asked Questions about your Short-Term Disability

Am I eligible for coverage?	You are eligible if you are working a minimum of 30 Hoursper week and considered benefit eligible by your employer.
Who pays for my coverage?	Your employer has made this coverage available to all eligible employees on a voluntary basis which means you pay your premiums if you elect the coverage.
When can I enroll in coverage?	If you are required to contribute to your coverage you may enroll during your open enrollment period which is defined by your employer. You have 31 days from the date you become eligible for the coverage to enroll. Contact your company HR representative to confirm.
What does it mean to be Disabled under this Short-Term Disability plan?	<p>You are considered Disabled or have a Disability when we determine that you are:</p> <ul style="list-style-type: none"> • not Actively at Work and you are unable to perform some or all of the Material and Substantial Duties of your regular job due to a Sickness or Injury; and • you have a loss in your weekly earnings (20% or more) due to your Sickness or Injury; and • you are under the Regular Care of a Physician
Can I keep my Short-Term Disability coverage if I leave my employer?	No, your Short-Term Disability coverage is not portable. You cannot take the coverage with you if you leave your employer.
Does my coverage reduce as I get older?	No, your Short-Term Disability benefits are calculated based on a portion of your earnings not your age.
When does my coverage go into effect?	You must be Actively at Work with your employer on the date your coverage is scheduled to take effect. Otherwise, your coverage takes effect when you return to Active Work.

Exclusions:

You cannot receive Short-Term Disability Insurance benefit payments for disabilities that are caused or contributed by:

- War or act of war (declared or not)
- The commission of, or attempt to commit a felony
- An intentionally self-inflicted injury
- Any case where your being engaged in an illegal occupation was a contributing cause to your disability
- Sickness or injury which Workers' Compensation benefits are paid, or may be paid, if duly claimed
- Any injury sustained as a result of doing work for pay or profit for another employer

*You must be under the regular care of a physician to receive benefits.

Your benefit payments **will be reduced** by other income you receive or are eligible to receive due to your disability, including but not limited to:

- Social Security Disability Insurance
- Workers' Compensation
- Other employer-based insurance coverage you may have
- Unemployment benefits
- Settlements or judgments for income loss
- Retirement benefits that your employer fully or partially pays for (such as pension plan)
- Employer's sick leave or salary continuation plan
- Loss of time or lost wages from no-fault motor vehicle insurance plan

Premium Calculation Example:

Voluntary Short-Term Disability

To calculate the cost of coverage, use the formula below:

$$\frac{\text{Annual Earnings}}{52} \text{ OR } \frac{\text{Weekly Earnings}}{\text{Benefit \%}} = \text{Weekly Covered Benefit}$$

$$\frac{\text{Weekly Covered Benefit}}{\text{Rate (from table)}} = \frac{\text{Subtotal}}{10} = \text{Cost Per Month}$$
